1. Background and Narrative of Budget Reductions:

District has implemented cost cuts beginning in 2015-2016 of \$1.5 million, including salaries of \$1.15 million and Administrative reduction of \$100,000. Cuts were also made for 2016-17. District will also benefit from retirements of certified and non-certified staff that will not be replaced.

2. Assumptions Used in the Deficit Reduction Plan:

- Foundation Levels for General State Aid:

We expect the State of Illinois to increase the foundation level and fund 100% of the State Aid. We are also hopeful for State of Illinois to change the funding formula to make it more adequate and equitable.

- Equal Assessed Valuation and Tax Rates:

EAV is currently \$118,177,996, which is an increase of \$23,176 over the 2012 EAV. We expect this to increase with new construction around the county. We also expect to see an increase in farmland assessments.

- Employee Salaries and Benefits:

This is year four of a four-year CBA with the Certified Union and year five of a five-year CBA with the Non-Certified Union. We have RIF's and non-renewed multiple positions. We will begin negotiations with both groups after January 1, 2017.

- Short and Long Term Borrowing:

Short-term borrowing consists of five-year bus leases that will be paid off. Long-term borrowing consists of working cash bonds.

- Educational Impact:

We expect educational quality to continue.
